**1 When and where is the RWC Annual General Meeting?**

RWC is holding an in person Annual General Meeting this year. Details are:

**2 Will there be a live webcast of the meeting?**

RWC will not be providing a webcast of the meeting.

**3 What do I need to do to register to attend?**

Shareholders and visitors should arrive before the commencement of the meeting and register upon arrival. Pre-registration is not required.

**4 What happens if circumstances change and an in-person meeting cannot be held?**

The General Meeting will be held as an in-person meeting. If circumstances change in a way which impacts the holding of an in-person General Meeting, the Company will provide an update by announcement to the ASX and on its website. Shareholders are encouraged to check the ASX announcements platform (ASX Code: RWC) and the Company's website for any updates in connection with the General Meeting.

**5 How do I ask a question at the meeting?**

Shareholders entitled to vote at the meeting will be given a reasonable opportunity to ask questions in connection with the management of the Company and on the specific items of business being considered at the meeting.

The Chairman will announce when questions can be asked.

**6 How do I vote at the meeting**

All voting at the meeting will be conducted by way of a poll. The Chairman will advise when the voting period opens and closes.

**7 How do I vote or submit questions prior to the meeting?**

Shareholders are encouraged to vote or submit written questions prior to the meeting.
